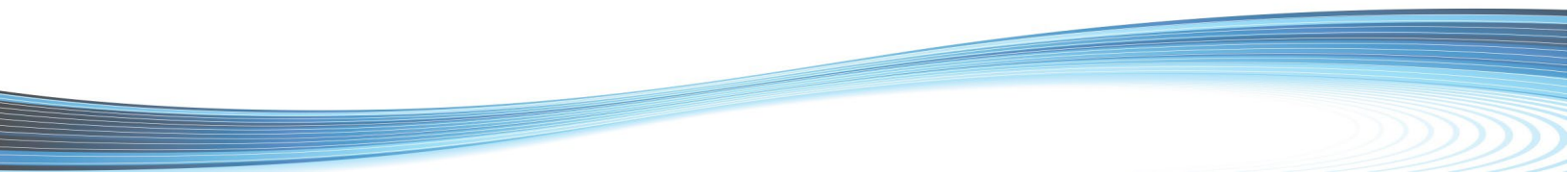

Introduction

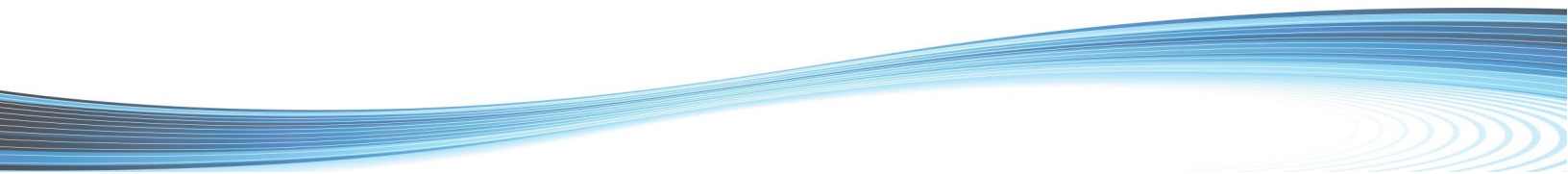

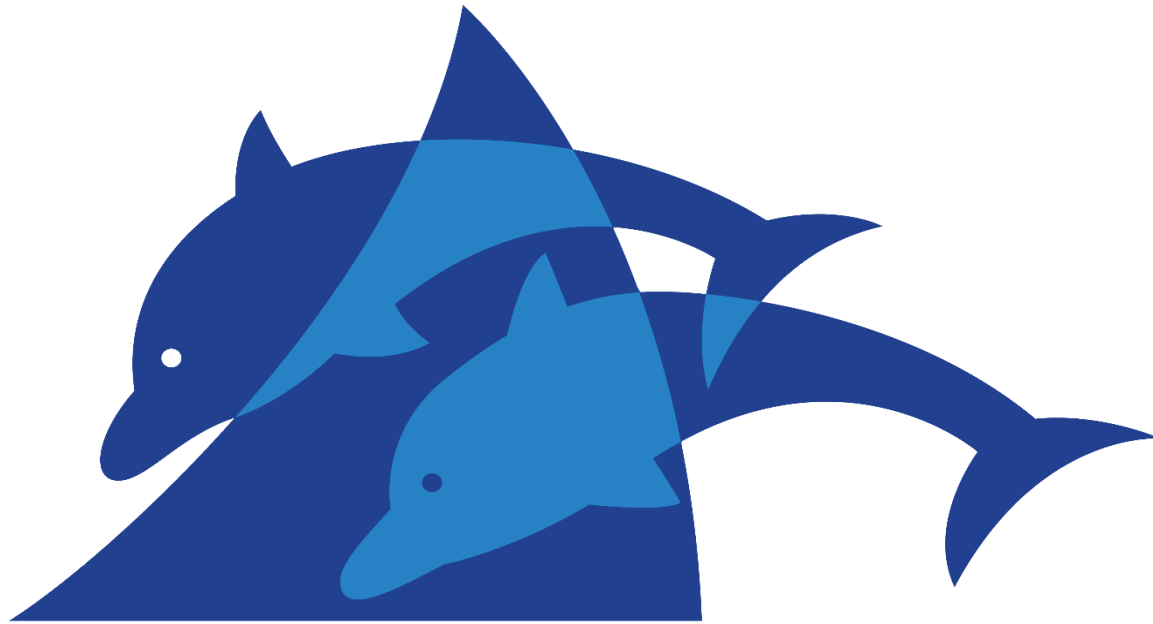
